## REPORTS OF CHIEF CLERK

S. F. No. 1614 and H. F. No. 1817, which had been referred to the Chief Clerk for comparison, were examined and found to be identical.

Kohls moved that S. F. No. 1614 be substituted for H. F. No. 1817 and that the House File be indefinitely postponed. The motion prevailed.

S. F. No. 2299 and H. F. No. 2365, which had been referred to the Chief Clerk for comparison, were examined and found to be identical with certain exceptions.

## SUSPENSION OF RULES

Hoppe moved that the rules be so far suspended that S. F. No. 2299 be substituted for H. F. No. 2365 and that the House File be indefinitely postponed. The motion prevailed.

#### INTRODUCTION AND FIRST READING OF HOUSE BILLS

H. F. No. 3166, A resolution memorializing Congress to reauthorize the wind power producer credit.

The bill was read for the first time and referred to the Committee on Regulated Industries.

Murphy, Huntley, Sertich, Rukavina and Rhodes introduced:

H. F. No. 3167, A bill for an act relating to employment; prohibiting broadcast employers from including noncompete provisions in employment agreements; proposing coding for new law in Minnesota Statutes, chapter 181.

The bill was read for the first time and referred to the Committee on Commerce, Jobs and Economic Development.

Kohls, Buesgens, Holberg and Smith introduced:

H. F. No. 3168, A bill for an act relating to child protection; requiring certain notice to the subject of a child maltreatment report; requiring certain training for child abuse services professionals; amending Minnesota Statutes 2002, section 626.559, subdivision 2; Minnesota Statutes 2003 Supplement, section 626.556, subdivision 10.

The bill was read for the first time and referred to the Committee on Civil Law.

Kelliher, Thissen, Latz, Greiling, Mahoney, Sertich, Mariani, Hilty, Sieben, Murphy and Otremba introduced:

H. F. No. 3169, A bill for an act relating to human services; creating parents as scholars pilot project; appropriating money.

The bill was read for the first time and referred to the Committee on Health and Human Services Policy.

Abrams, Lenczewski, Atkins and Jacobson introduced:

H. F. No. 3170, A bill for an act relating to tax increment financing; making technical and minor policy changes; amending Minnesota Statutes 2002, sections 469.174, subdivision 11; 469.175, subdivision 4a; 469.176, subdivision 4d; 469.1761, subdivision 1; 469.1771, subdivision 5; 469.178, subdivision 1; Minnesota Statutes 2003 Supplement, sections 116J.556; 469.174, subdivision 25; 469.177, subdivision 1; repealing Minnesota Statutes 2002, sections 469.176, subdivision 1a; 469.1766.

The bill was read for the first time and referred to the Committee on Taxes.
