(c) The transfers and cancellations under this section are onetime."

Page 1, line 19, after "roads" insert "and bridges"

Page 1, line 20, after the period, insert "This is a onetime appropriation."

Page 2, line 2, delete "(a)"

Page 2, delete lines 7 to 14

Page 2, after line 18, insert:

"(c) The appropriation in this section is onetime."

Amend the title as follows:

Page 1, line 4, after "roads" insert "and bridges"

With the recommendation that when so amended the bill be placed on the General Register.
