Subdivision 1. Minnesota Law Enforcement Association. The labor agreement between the state of Minnesota and the Minnesota Law Enforcement Association, submitted to the Legislative Coordinating Commission Subcommittee on Employee Relations on April 5, 2019, is ratified.

Subd. 2. Minnesota State Board of Investment salary administration plan. The salary administration plan for the Minnesota State Board of Investment, submitted to the Legislative Coordinating Commission Subcommittee on Employee Relations on February 7, 2019, is ratified.

# Sec. 2. **EFFECTIVE DATE.**

Section 1 is effective the day following final enactment."

H. F. No. 2899, A bill for an act relating to education; administration of drugs and medicines; requiring a report.

The bill was read for the first time and referred to the Committee on Education Policy.

Jurgens introduced:

H. F. No. 2900, A bill for an act relating to state government; limiting paid leave for state employees who are subjects of investigations; amending Minnesota Statutes 2018, section 43A.05, by adding a subdivision.

The bill was read for the first time and referred to the Committee on Government Operations.

Baker, Schomacker and Long introduced:

H. F. No. 2901, A bill for an act relating to public safety; establishing a temporary subcommittee of the Minnesota Recovers Task Force; requiring reports; appropriating money.

The bill was read for the first time and referred to the Committee on Ways and Means.

Lillie, Wagenius and Hansen introduced:

H. F. No. 2902, A bill for an act relating to water; establishing the Legislative-Citizen Commission on Minnesota Waters; eliminating the Clean Water Council and Legislative Water Commission; reassigning duties; providing appointments; amending Minnesota Statutes 2018, sections 3.886, subdivision 6; 10A.01, subdivision 35; 97A.056, subdivision 3; 114D.35, subdivisions 2, 3; 114D.50, subdivision 4; proposing coding for new law in Minnesota Statutes, chapter 114D; repealing Minnesota Statutes 2018, sections 114D.15, subdivision 3; 114D.20, subdivisions 5, 6, 7; 114D.30.

The bill was read for the first time and referred to the Committee on Environment and Natural Resources Policy.

Kotyza-Witthuhn, Morrison, Bahner, Kunesh-Podein, Pinto and Carlson, A., introduced:

H. F. No. 2903, A bill for an act relating to education; requiring schools to make disposable menstrual products freely available in school restrooms; amending Minnesota Statutes 2018, section 121A.21.

The bill was read for the first time and referred to the Committee on Education Policy.

Edelson and Zerwas introduced:

H. F. No. 2904, A bill for an act relating to crime; providing a procedure to determine a defendant's competence; proposing coding for new law in Minnesota Statutes, chapter 628.

The bill was read for the first time and referred to the Public Safety and Criminal Justice Reform Finance and Policy Division.

## REPORTS OF STANDING COMMITTEES AND DIVISIONS

Carlson, L., from the Committee on Ways and Means to which was referred:

H. F. No. 850, A bill for an act relating to natural resources; appropriating money to address wildlife disease.

Reported the same back with the following amendments:

Delete everything after the enacting clause and insert:

## "Section 1. WILDLIFE DISEASE MANAGEMENT; CHRONIC WASTING DISEASE APPROPRIATIONS.

- (a) \$2,060,000 in fiscal year 2020 and \$1,460,000 in fiscal year 2021 are appropriated from the general fund to the commissioner of natural resources for planning for and emergency response to disease outbreaks in wildlife. Of this amount:
  - (1) \$50,000 in fiscal year 2020 is to establish a chronic wasting disease adopt-a-dumpster program;
- (2) \$50,000 in fiscal year 2020 is to develop guidelines for handling, transporting, processing, and disposing of deer carcasses; and
- (3) \$500,000 in fiscal year 2020 is for a grant to the Board of Regents of the University of Minnesota for the Chronic Wasting Disease Response, Research, and Policy Program.

The commissioner and board must each submit quarterly reports on the activities funded under this paragraph to the chairs and ranking minority members of the legislative committees and divisions with jurisdiction over environment and natural resources and agriculture. Base funding for this activity is \$1,100,000 in fiscal year 2022 and thereafter.

(b) If the appropriations in this section are enacted more than once in the 2019 regular legislative session, the appropriations must be given effect only once."

With the recommendation that when so amended the bill be placed on the General Register.

The report was adopted.

Carlson, L., from the Committee on Ways and Means to which was referred:

S. F. No. 973, A bill for an act relating to health; requesting the Board of Regents of the University of Minnesota to establish an advisory council on rare diseases; appropriating money; proposing coding for new law in Minnesota Statutes, chapter 137.

Reported the same back with the following amendments:

Page 3, line 31, delete "\$50,000" and insert "\$150,000" and delete "\$50,000" and insert "\$150,000"

Page 4, line 1, delete everything after the period and insert "This is a onetime appropriation."

Page 4, delete line 2 and insert:

## "Sec. 3. APPROPRIATIONS ENACTED MORE THAN ONCE; EFFECT.

If an appropriation in this act is enacted more than once in the 2019 legislative session, the appropriation must be given effect only once."

With the recommendation that when so amended the bill be placed on the General Register.

"Section 1. Minnesota Statutes 2018, section 626.93, is amended by adding a subdivision to read:

Subd. 7. Exception; Prairie Island Indian Community. Notwithstanding any contrary provision in subdivision 3 or 4, the Prairie Island Indian Community of the Mdewakanton Dakota tribe has concurrent jurisdictional authority under this section with the local county sheriff within the geographical boundaries of the community's reservation to enforce state criminal law if the requirements of subdivision 2 are met, regardless of whether a cooperative agreement pursuant to subdivision 4 is entered into."

S. F. No. 1100, A bill for an act relating to public safety; modifying requirements for the Prairie Island Indian Community to exercise concurrent state law enforcement jurisdictional authority; amending Minnesota Statutes 2018, section 626.93, by adding a subdivision.
