Please be advised that I have received, approved, signed, and deposited in the Office of the Secretary of State the following House Files:

SPECIAL SESSION

H. F. No. 6, relating to transportation; establishing a budget for transportation; appropriating money for transportation purposes, including Department of Transportation, Metropolitan Council, and Department of Public Safety activities; providing grants to deputy registrars; requiring the purchase and implementation of a vehicle title and registration system to replace the Minnesota Licensing and Registration System (MNLARS); modifying various fees and surcharges; establishing committees and task forces; establishing accounts; modifying various provisions governing transportation policy and finance; making technical changes; requiring reports.

H. F. No. 5, relating to financing and operation of state and local government; providing conformity and nonconformity to certain federal tax law changes; modifying individual income and corporate franchise taxes, estate taxes, sales and use taxes, special and excise taxes, property taxes, local government aids, provisions related to local taxes, tax increment financing, and public finance, and other miscellaneous taxes and tax provisions; modifying indexing provisions; changing the starting point for state individual income tax calculation from federal taxable income to federal adjusted gross income; providing for various individual and corporate additions and subtractions to income; modifying certain allowances and adjustments to income; modifying individual income tax brackets; modifying certain income tax credits; modifying and allowing certain exemptions from sales and use taxes; establishing property tax exemptions; modifying agricultural homestead provisions; modifying state general levy; modifying certain deadlines; modifying referendum equalization levy; phasing out school building bond agricultural credit; modifying aid and providing grants to cities and counties; modifying approval requirements for certain local sales taxes; modifying and authorizing certain local sales taxes; requiring reports; appropriating money.
