Please be advised that I have received, approved, signed, and deposited in the Office of the Secretary of State the following House Files:

H. F. No. 2073, relating to higher education; providing funding and policy related changes for the Office of Higher Education, Minnesota State Colleges and Universities, the University of Minnesota, and the Mayo Clinic; creating and modifying certain scholarships and student aid programs; creating and modifying grant programs to higher education institutions; establishing the North Star Promise tuition free program; establishing the Inclusive Higher Education Technical Assistance Center; creating a direct admissions program; providing aid to postsecondary institutions for unemployment insurance; establishing a student basic needs working group; requiring reports; appropriating money.

H. F. No. 1403, relating to human services; modifying and establishing laws regarding aging, disability, behavioral health, substance use disorder, and statewide opioid litigation.

H. F. No. 2292, relating to early childhood; modifying provisions for early learning scholarships, Head Start, and early education programs; providing for early childhood educator programs; requiring reports; appropriating money.

H. F. No. 2497, relating to education finance; providing funding for prekindergarten through grade 12 education; modifying provisions for general education, education excellence, literacy, American Indian education, teachers, charter schools, special education, facilities, nutrition, libraries, early childhood, community education, and state agencies; making forecast adjustments; providing for rulemaking; requiring reports; appropriating money.

H. F. No. 2, relating to state government; providing for paid family, bonding, and applicant's serious medical condition benefits; regulating and requiring certain employment leaves; authorizing income tax withholdings and imposing taxes; authorizing penalties; classifying data; authorizing rulemaking; requiring an actuarial report; appropriating money.

H. F. No. 2310, relating to state government; appropriating money for environment, natural resources, climate, and energy; appropriating money from environment and natural resources trust fund; modifying prior appropriations; providing for and modifying disposition of certain receipts; modifying and establishing duties,

authorities, and prohibitions regarding environment and natural resources; modifying and creating environment and natural resources programs; modifying and creating grant programs; modifying permit and environmental review requirements; modifying requirements for recreational vehicles; modifying state trail, state forest, and state park provisions; authorizing sales, conveyances, and leases of certain state lands; modifying forestry provisions; modifying game and fish provisions; modifying regulation of farmed Cervidae; regulating certain seeds and pesticides; modifying Water Law; modifying and providing for fees; establishing a biennial budget for Department of Commerce, Public Utilities Commission, and energy, climate, and clean energy activities; establishing and modifying provisions governing energy, clean and renewable energy, energy storage, energy use and conservation, and utility regulation; adding and modifying provisions governing Public Utilities Commission proceedings; making technical changes; requiring reports; requiring rulemaking.

No. 1830, relating to government operations; establishing a biennial budget; appropriating money for the legislature, certain constitutional offices and state agencies, Minnesota Historical Society, Minnesota Humanities Center, State Lottery, certain retirement accounts, certain offices, departments, boards, commissions, councils, general contingent account, and tort claims; transferring certain funds; providing revenue recapture; requiring appropriation reduction for executive agencies; canceling a certain general fund appropriation; making changes to policy provisions for state government operations, local government policy, elections administration, campaign finance, information technology and cybersecurity, grants oversight, and state employees with disabilities; providing penalties; requiring reports.

H. F. Dear Speaker Hortman:

Rideshare drivers deserve safe working conditions and fair wages, and I am committed to finding solutions to these issues that balance the interests of all Minnesotans, drivers and riders alike. However, House File 2369 is not the right bill to achieve these goals and is simply not ready to be codified in Minnesota law. For these reasons, I have vetoed and am returning Chapter 65, House File 2369, a bill related to transportation network company (TNC) drivers.

This bill could make Minnesota one of the most expensive states in the country for rideshare, potentially putting us on par with the cost of rides in New York City and Seattle—cities with dramatically higher costs of living than Minnesota. Without objective, Minnesota-specific data, we do not have a clear understanding of the impacts on riders, drivers, and rideshare companies. And without a better understanding of these impacts, it would be imprudent to dramatically raise the cost of rideshares, especially for low-income Minnesotans, those in the disability community who depend on rideshares for independence, people who use rideshare for medical transportation or to get to work, Minnesotans without cars, and Minnesotans who simply need a safe ride home at night.

Moreover, disability advocates, anti-violence organizations, and organizations representing seniors, childcare centers, and local governments have all raised significant concerns about the impact of this bill. Those groups are united in their concern about how increased rideshare rates will limit, and potentially eliminate, needed transportation options for vulnerable communities. With public transportation options not uniformly available to all Minnesotans, it is imperative to maintain current affordable, accessible rideshare service options.

I have spent my career fighting for fair wages and safe working conditions for workers, and I will continue to work with drivers, riders, and rideshare companies to address the concerns that this bill sought to address. Today I will issue an executive order to bring together legislators, drivers, rideshare companies, members of the disability community, labor, riders, and others to continue working on this important topic and issue recommendations for the next legislative session.

I look forward to working with the legislature to develop solutions that deliver on the promise of fair compensation and safe working conditions for drivers while still providing affordable transportation options for Minnesotans.
